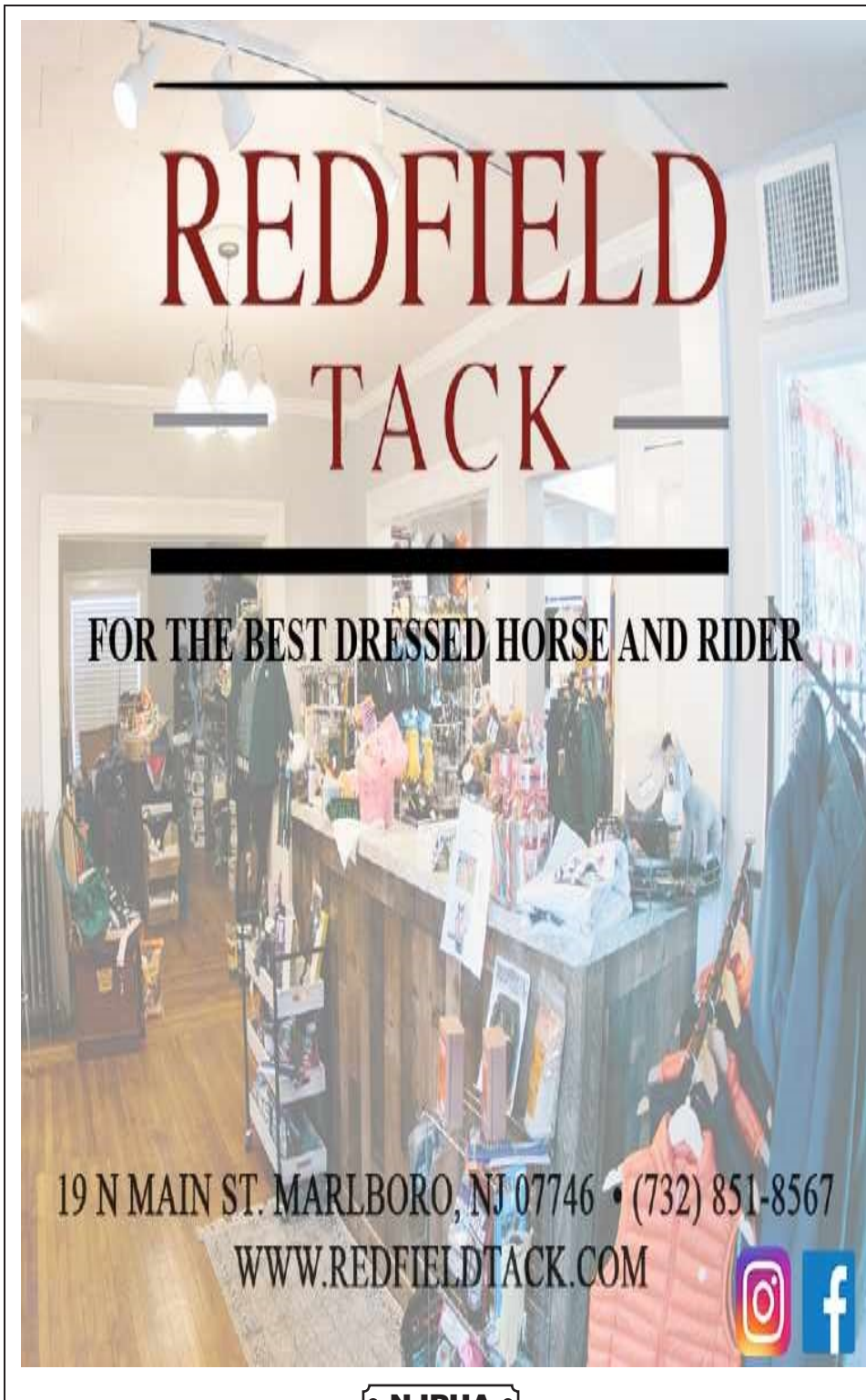

FALL FINALE RULES

1. Open to exhibitors from NJ, NY, & PA.
2. Entries close MONDAY SEPTEMBER 30th, 2024.
3. Entry fee is \$200.00 per division, no individual classes may be entered.
4. Qualifying criteria is you must have earned 2 champions or reserves or a combination of both. The only divisions which require 1 blue ribbon to qualify are the modified rider and the children's equitation.
5. Classes will be limited to 20 riders. all qualifying entries will be processed in the order they are received. A wait list will be started from the order received.
6. Accepted riders will be POSTED ON HORSESHOWING.COM
7. \$50.00 scratch fee will be assessed. No refunds after SEPTEMBER 30, 2024
8. Late charge of \$50.00 after the closing date, 09/30/2024.
9. Entry blank must be completed, accompanied by payment and signed to be processed.
10. Exhibitors must be in proper riding attire & protective head gear.
11. Exhibitors must wear their back number while schooling. (Mini Stirrup)
